LARKSFIELD PLACE Coordinated Care

Coordinated Care Services at Larksfield Place are designed to foster continued independence for residents. By choosing a plan and working with our nursing team to develop an individualized care plan, our shared goal of maintaining your residence in your Independent Living apartment may be achievable for a longer period of time as your health needs change. Three enhanced service options are offered to assist you.

THE PURPOSE:

- To coordinate care needs of a resident and facilitate nursing oversight for those on services.
- To promote aging in place within safe boundaries for an IL resident.
- To facilitate communication of residents and family members with Larksfield to plan and support changing healthcare needs in Independent Living.
- To facilitate a move to another level of living within Larksfield when a resident's needs can no longer be safely met in Independent Living.

IL RESIDENTS REQUIRING MORE COORDINATED CARE THAN ESTABLISHED ABOVE

If/when the time comes where an Independent Living resident requires extensive care services, for example:

- Assistance with ambulation
- Incontinence care
- Assistance with eating
- Experiencing frequent falls
- Overall hygiene-maintaining dignity
- Cueing for safety or cognition concerns (wandering, lack of time orientation, managing apartment)
- Resisting care and/or not complying with recommendations of Care Coordination team

It will become the sole determination of the care coordination team and Larksfield Place to move the resident to the appropriate care setting.

PLAN A:

- Up to 4 hours weekly of care services planned by a nurse in consultation with resident.
- Bundled payment of \$450.00 per month, represents a 20% discount from ala carte rates.

Examples of Care Services Available:

Bathing assist, Medication Management-setup/orders, Med Reminders, Blood Sugar Monitoring, TED hose assist, O2 Management, Laundry assist, Light Housekeeping, 1 Meal Delivery per day.

PLAN B:

- 4 7 hours weekly of care services planned by a nurse in consultation with resident.
- Bundled payment of \$800.00 per month, represents a 20% discount from ala carte rates.

Examples of Care Services Available:

Wellness Checks AM & PM, Dressing, Bathing assist, Medication Management-setup/orders, Med Reminders, Blood Sugar Monitoring, TED hose assist, O2 Management, Laundry assist, Light Housekeeping, one Meal Delivery per day.

PLAN C:

- 8 10 hours weekly of care services planned by a nurse in consultation with resident.
- Bundled payment of \$1,150.00 per month, represents a 20% discount from ala carte rates.

Examples of Care Services Available:

Wellness Checks AM & PM, Dressing, Bathing assist, Medication Management-setup/orders, Med Reminders, Blood Sugar Monitoring, TED hose assist, O2 Management, Laundry assist, Light Housekeeping, One Meal Delivery per day.

Additionally, all plans include:

- Care review and oversight
- LTC insurance filing
- Episodic health checks
- Care coordination w/Dr. (appointments, Rx, updates, etc.)
- Communication updates w/family per resident request

Services are offered individually; the Care Team will determine your level of service need.

Couples would have individual services as needed.

NOT AVAILABLE IN INDEPENDENT LIVING

- Routine incontinence assistance
- Extensive cueing for task completion
- Assistance exiting in emergency (physical or alerting)
- Support services exceeding 10 hours per week
- Assist with ambulation

Coordinated Care Services are designed as a support to Independent Living residents, enabling them to remain in their homes as long as safely possible. Coordinated Services are not designed to provide support to residents past a level where a resident's safety is compromised due to their physical and/or mental abilities. As dependence on Coordinated Care Services increases, a resident's well-being and appropriateness of current residency will be reviewed. This is done in conversation with the resident and DPOA as needed to determine which area of campus best suits the resident's overall needs. Per the Larksfield Place contract, while our goal is to reach an agreeable arrangement, Larksfield does have the final determination for where a resident resides on campus.
